EXPLANATORY NOTE: DEREGISTRATION OF SECURITIES

This Post-Effective Amendment No. 1 to the Registration Statement on Form S-8, Registration No. 333-103555 (the "Registration Statement"), is being filed to deregister certain shares of Quest Diagnostics Incorporated (the "Company") common stock (the "Shares") that were registered for issuance pursuant to the Amended and Restated Unilab Corporation 2000 Executive Stock Option Plan (the "2000 Executive Stock Option Plan") and the Unilab Corporation 2001 Stock Option Plan (the "2001 Stock Option Plan"). The Registration Statement, which was filed with the Securities and Exchange Commission on March 3, 2003, registered 191,933 Shares issuable pursuant to the 2000 Executive Stock Option Plan and 100,371 Shares issuable pursuant to the 2001 Stock Option Plan.
