Mandatory Redemption:	Mandatory redemption at 101% of the aggregate principal amount of the Notes together with accrued and unpaid interest, if the acquisition of Lone Star Technologies Inc. is not completed on or prior to October 1, 2007.

Optional Redemption: Optional redemption at any time in whole, or from time to time in part, at a redemption price equal to the greater of (i) 100% of the principal amount of the Notes redeemed and (ii) the sum of the present values of remaining scheduled payments of principal and interest (exclusive of interest accrued to the date of redemption) on such Notes discounted to the redemption date on a semi-annual basis at the Treasury yield plus 15 basis points, plus accrued interest to the redemption date.

Change of Control Repurchase Event: If a change of control repurchase event occurs, the Company will be required to make an offer to repurchase all outstanding Notes at a price in cash equal to 101% of the principal amount of the Notes, plus any accrued and unpaid interest to but not including the repurchase date.
