The awards include the right to have stock withheld for tax purposes.
- (2) These shares represent a retention award of restricted stock under the Abbott Laboratories 1996 Incentive Stock Program. This award generally will vest 29 months from the date of grant and include the right to have stock withheld for tax purposes.
- (3) Employee stock option granted pursuant to the Abbott Laboratories 1996 Incentive Stock Program in a transaction exempt from Section 16(b) under Rule 16b-3. The option becomes exercisable in annual increments of 7,334 on 07/30/2008, 7,333 on 07/30/2009, and 7,333 on 07/30/2010.
