(1) The reporting person was granted 5,500 restricted stock units on July 31, 2008, of which 3,300 vested immediately. The transaction reported herein represents the vesting of one-half of the 2,200 restricted stock units that did not vest immediately. The award has fully vested. Each unit converts into a share of common stock on a one-for-one basis.

(2) The transaction reported herein represents the vesting of one-fifth of 10,000 restricted stock units granted on July 31, 2008.
