- (1) A total of 80,000 options were granted on 04/26/2007. 29,903 options were vested and exercisable as of 11/01/2016.
- (2) Option exercise and sale pursuant to a 10b5-1 plan established to allow the exercise and sale of options which will be forfeited if not exercised prior to the April 26, 2017 expiration date.
- (3) The shares reported in column 4 were sold in multiple transactions with a weighted average price of \$35.15 per share.
