- (1) On March 19, 2018, the reporting person transferred 26,289 shares of Class A common stock from his direct holdings into his trust. Restricted Stock Units ("RSUs") granted under the Plan. Each RSU represents the right to receive, following vesting, one share of MGM Resorts common stock. The RSUs will vest in four equal annual installments commencing on the first anniversary of the grant date, subject to the terms of the Plan and applicable award agreement.
- (2) Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on MGM Resorts International's common stock and vest on the same dates and in the same relative proportions as the RSUs on which they accrue.
- (3) RSUs granted under the Plan. Each RSU represents the right to receive one share of MGM Resorts common stock.
- (4) The RSUs are fully vested. Delivery of shares will be made on the third anniversary of the grant date.
