(1) These shares are part of 1,000,000 shares owned by Cotter Enterprises, LLC, in which the Cotter 2005 Children's Trust U/D/T dated December 31, 2005 (the "Trust") holds a 99% non-voting interest. Ms. Cotter is a trustee of the Trust and is one of three equal beneficiaries of the Trust and, as such, has a pecuniary interest in the shares shown.

(2) Price reflects the price paid for a 33% non-voting interest in Cotter Enterprises, LLC, and represents a discount from the value of the underlying securities reflecting the illiquid and non-controlling nature of the limited liability company membership interest involved. The price is subject to adjustment upward or downward based on a third party appraisal, which is currently in process.
