#### ITEM 1. SECURITY AND ISSUER

This statement relates to the common stock, of Poker Magic, a Minnesota corporation (the "Issuer"). The address of Issuer's principal executive offices is 130 Lake Street West, Suite 300, Wayzata, MN 55391.

#### ITEM 2. IDENTITY AND BACKGROUND

This Schedule 13D is being filed by Joseph A. Geraci, II. Mr. Geraci was a co-founder of the Issuer and is currently Chief Financial Officer and a director of the Issuer. His business address is 80 South 8th Street, Suite 900, Minneapolis, MN 55402.

During the last five years, Mr. Geraci has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).

During the last five years, Mr. Geraci has not been a party to a civil proceeding of any judicial or administrative body of competent jurisdiction resulting in any judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

Mr. Geraci is a citizen of the United States of America.

### ITEM 4. PURPOSE OF TRANSACTION

The Reporting Person has not formulated any definitive plans. ### ITEM 5. INTEREST IN THE SECURITIES OF THE ISSUER

The Reporting Person may be deemed to beneficially own 1,696,000 shares of the Issuer's common stock, 1,691,000 of these shares are held directly and Mr. Geraci has sole voting and dispositive power over these shares. Also includes 5,000 shares held by Lantern Advisers, LLC, a Minnesota limited liability company, of which Mr. Geraci is a member. Mr. Geraci shares voting and dispositive power with respect to these shares.

The number of shares reported in Item 11 (on page 2), and indicated above, excludes 190,000 shares held by Mr. Geraci's spouse (see Exhibit A attached hereto).

According to the most recently filed Quarterly Report on Form 10-Q of the Issuer, as of November 2, 2009, 9,763,224 shares of common stock were issued and outstanding. Based on such report Mr. Geraci owns 17.4% of the outstanding common shares of the Issuer.
