This option was cancelled as a result of the completion of the tender offer that expired on January 28, 2011 in exchange for cash payment (2) of \$229,800, representing the difference between the exercise price of the option and the offer price (\$38.00 per share) pursuant to the Agreement and Plan of Merger, dated December 18, 2010, between the issuer, Raytheon Company and RN Acquisition Company.
