Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned in column 9 includes 18.0747 dividend equivalent rights at \$53.29 per RSU credited to the reporting person's account on 04/07/10.
