The 6.3302 dividend equivalent rights being reported reflect 2.3390 dividend equivalent rights at \$41.18 per RSU credited to the reporting person's account on 04/06/11, and 3.9912 dividend equivalent rights at \$36.20 per RSU credited to the reporting person's account on 07/06/11.
 - (4) As previously reported, on 12/10/10 the reporting person was granted 2,834 restricted stock units ("RSUs"), 1,417 of which will vest on each of 12/10/11 and 12/10/12. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 14.9001 dividend equivalent rights being reported reflect 5.5056 dividend equivalent rights at \$41.18 per RSU credited to the reporting person's account on 04/06/11, and 9.3945 dividend equivalent rights at \$36.20 per RSU credited to the reporting

Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
