### Item 8.01. Other Events

Innospec Inc. announced by a press release dated August 18, 2006, that its Board of Directors had declared a semi-annual dividend of \$0.08 cents (eight cents) per share on common stock. The cash dividend will be payable on October 1, 2006 to holders of record of the Corporation's common stock at close of business on September 1, 2006.

The Corporation also announced that its Board of Directors had authorized a Rule 10b5-1 stock repurchase plan to facilitate repurchases of its common stock up to a value of \$2 million. The repurchase plan is intended to run up to October 24, 2006.
