**Item 7.01. Regulation FD Disclosure**

On November 16, 2009, Casey's General Stores, Inc. (the "Company") reported October 2009 same-store sales results for stores open for one full year. Same store gasoline gallons sold decreased 4.0% in October 2009 compared to October 2008. The gasoline margin was above the Company's fiscal 2010 goal of 11.0 cents per gallon. The average retail price of gasoline sold during October 2009 was \$2.42 per gallon. Same-store sales for prepared food and fountain increased 1.7% and grocery and other merchandise decreased 1.8% in October 2009 compared to October 2008, notwithstanding an approximately 2.0% increase resulting from the recent federal excise tax increase on cigarettes.
