- (1) The entity directly acquiring the shares reported in this filing is SPO Partners II, L.P. ("SPO Partners"), which bought 10 shares of the issuers common stock, at a price of 17.38.
- As a result of the purchase causing this filing, 9,513,410 of these shares are owned directly by SPO Partners, and may be deemed to be indirectly beneficially owned by (i) SPO Advisory Partners, L.P. ("SPO Advisory"), the sole general partner of SPO Partners, (ii) SPO Advisory Corp. ("SPO Corp."), the sole general partner of SPO Advisory, and (iii) John H. Scully ("JHS"), William E. Oberndorf ("WEO") and Edward H. McDermott ("EHM"), the three controlling persons of SPO Corp. Additionally, 327,900 of these shares are owned directly by San Francisco Partners, L.P. ("SF Partners"), and may be deemed to be indirectly beneficially owned by (i) SF Advisory Partners, L.P. ("SF Advisory"), the sole general partner of SF Partners, (ii) SPO Corp., the sole general partner of SF Advisory, and (iii) JHS, WEO and EHM, the three controlling persons of SPO Corp.
- (2) Additionally, (i) 3,100 shares are directly owned by JHS and are held in an IRA, which is self-directed, (ii) 74,300 shares are directly owned by WEO and are held in an IRA, which is self-directed and (iii) 800 shares are directly owned by EHM and are held in an IRA, which is self-directed.
- (3) Additionally, 8,169,525 warrants are owned directly by SPO Partners, and may be deemed to be indirectly beneficially owned by (i) SPO Advisory, the sole general partner of SPO Partners, (ii) SPO Corp., the sole general partner of SPO Advisory, and (iii) JHS, WEO and EHM, the three controlling persons of SPO Corp. Additionally, 279,753 warrants are owned directly by SF Partners, and may be deemed to be indirectly beneficially owned by (i) SF Advisory, the sole general partner of SF Partners, (ii) SPO Corp., the sole general partner of SF Advisory, and (iii) JHS, WEO and EHM, the three controlling persons of SPO Corp.
- (4) Additionally, (i) 813 warrants are directly owned by JHS and are held in an IRA, which is self-directed, (ii) 61,588 warrants are directly owned by WEO and are held in an IRA, which is self-directed and (iii) 622 warrants are directly owned by EHM and are held in an IRA, which is self-directed.
