Charitable Remainder Unitrust is an irrevocable trust, of which Lafayette College is the sole trustee. S. Kent Rockwell disclaims all beneficial ownership of the shares gifted to The Rockwell Holdings, Inc. Charitable Remainder Unitrust.
- (2) S. Kent Rockwell is the beneficiary of the S. Kent Rockwell Revocable Trust, which is the indirect, sole stockholder of Rockwell Forest Products, Inc. and Rockwell Holdings, Inc. which are the record holders of the shares beneficially owned by Mr. Rockwell. This filing includes Rockwell Forest Products as the 10% holder of 4,176,000 shares and, after taking the gift described above into account, 305,027 shares held by Rockwell Holdings, Inc.
