Transaction in Own Shares

The Company has today purchased 180,000 of its Ordinary Shares of US 20¢ each through JP Morgan Cazenove, in accordance with the authority granted by shareholders at the Company's Annual General Meeting on 11 April 2013.

The average price paid was 805.7825p per share.

The highest price paid was 808p per share and the lowest price paid was 802.75p per share.

The Company intends to hold these shares in Treasury.

The Company has also today transferred 14,340 Ordinary Shares of US 20¢ each out of Treasury to participants in the Smith & Nephew ShareSave Plan and the Smith & Nephew International ShareSave Plan as follows:

11,962 Ordinary Shares at an exercise price of 461p per share.

2,378 Ordinary Shares at an exercise price of 507p per share.

Following the above transactions, the Company holds 30,741,773 of its shares in Treasury. The Company's issued share capital, with one voting right per share consists of 894,651,935 Ordinary Shares of US20¢ each. This is the figure which should be used by shareholders as the denominator when determining whether they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure and Transparency Rules.
