**Excerpts from November 24, 2004 Teleconference/Webcast**

Q: Please discuss the proposed integration between UFJ Card, DC Card and Nippon Shinpan.

A: With regard to DC Card, we are still considering the relevant details and cannot discuss them at this time. Plans to complete the proposed integration by March 2005 have been postponed at this time. We understand that Nippon Shinpan has completed its plan to dispose of its bad loans, although we cannot discuss the relevant details at this time.

Q: Please discuss the status of MTFG's due diligence investigation of UFJ Holdings relating to the proposed merger between the two groups.

A: We are still aiming to complete the merger in October 2005. We currently feel that the merger ratio and other details may have to be determined at the latest by late April/early May 2005, so MTFG's financial, legal and other departments have begun conducting due diligence with that schedule in mind.

Mitsubishi Tokyo Financial Group, Inc. ( MTFG ) may file a registration statement on Form F-4 ( Form F-4 ) with the U.S. SEC in connection with the proposed management integration of UFJ Holdings, Inc. ( UFJ ) with MTFG. The Form F-4 (if filed) will contain a prospectus and other documents. If a Form F-4 is filed and declared effective, UFJ plans to mail the prospectus contained in the Form F-4 to its U.S. shareholders prior to the shareholders meeting at which the proposed business combination will be voted upon. The Form F-4 (if filed) and prospectus will contain important information about MTFG, UFJ, management integration and related matters. **U.S. shareholders of UFJ are urged to read the Form F-4, the prospectus and the other documents that may be filed with the U.S. SEC in connection with the management integration carefully before they make any decision at the UFJ shareholders meeting with respect to the proposed business combination.** The Form F-4 (if filed), the prospectus and all other documents filed with the U.S. SEC in connection with the management integration will be available when filed, free of charge, on the U.S. SEC's web site at [www.sec.gov](http://www.sec.gov).
