As previously announced, the Compensation and Human Resources Committee of the Board of Directors (the Committee) of Silicon Graphics, Inc. (the Company) approved the Company s Fiscal Year 2007 SGI Cash Bonus Plan (the Plan) in November 2006. A summary of the Plan was filed as Exhibit 10.1 to the Company s Quarterly Report on Form 10-Q, filed with the Securities and Exchange Commission on November 13, 2006. On August 28, 2007, the Committee approved the final performance scores pursuant to which bonuses for the Company s executive officers (other than Robert Ewald, the Company s Chief Executive Officer) are calculated under the Plan. Mr. Ewald s employment agreement dated April 9, 2007 provides for a guaranteed bonus, to be paid at the same time as bonuses awarded to the Company s other executives. In September 2007, the Company made the final bonus calculations based on the approved scores and bonuses were paid out on September 21, 2007.
