Item 8.01 Other Events.

Throughout this document, AT&T Inc. is referred to as AT&T. On November 27, 2013, AT&T closed its sale of \$1,600,000,000 principal amount of its 2.375% Global Notes due 2018 (the Fixed Rate Notes) and \$400,000,000 Floating Rate Global Notes due 2018 (the Floating Rate Notes and, together with the Fixed Rate Notes, the Notes) pursuant to the Underwriting Agreement, dated November 20, 2013 (the Underwriting Agreement), between AT&T and Citigroup Global Markets Inc. and Mizuho Securities USA Inc., as the representatives of the several Underwriters. The Notes were issued pursuant to that certain Indenture, dated as of May 15, 2013, between AT&T Inc. and The Bank of New York Mellon Trust Company, N.A., as Trustee. The Notes have been registered under the Securities Act of 1933 (the Act) pursuant to a Registration Statement on Form S-3 (No. 333-187350) previously filed with the Securities and Exchange Commission (the Commission) under the Act. Copies of the Underwriting Agreement, the form of Note and the opinion of our General Counsel as to the validity of the Notes are filed as exhibits hereto and incorporated herein by reference. AT&T is filing this Current Report on Form 8-K so as to file with the Commission certain items that are to be incorporated by reference into its Registration Statement.
