This Tender Offer Statement on Schedule TO (this Statement) relates solely to preliminary communications made before the commencement of a planned tender offer by Rocket Acquisition Corporation ( Purchaser ), a wholly-owned subsidiary of OC Acquisition LLC ( Parent ), a wholly-owned subsidiary of Oracle Corporation ( Oracle ) for all of the outstanding common stock of MICROS Systems, Inc. (the Company), to be commenced pursuant to the Agreement and Plan of Merger, dated as of June 22, 2014, among Parent, Purchaser, Oracle and the Company.

The tender offer has not yet commenced. This document is for informational purposes only and is neither an offer to purchase nor a solicitation of an offer to sell shares of the Company, nor is it a substitute for the tender offer materials that Oracle, Parent and Purchaser will file with the SEC upon commencement of the tender offer. At the time the tender is commenced, Oracle, Parent and Purchaser will file tender offer materials on Schedule TO, and the Company will file a Solicitation/Recommendation Statement on Schedule 14D-9 with the SEC with respect to the tender offer. The tender offer materials (including an Offer to Purchase, a related Letter of Transmittal and certain other tender offer documents) and the Solicitation/Recommendation Statement will contain important information. Holders of shares of the Company are urged to read these documents when they become available because they will contain important information that holders of Company securities should consider before making any decision regarding tendering their securities. The Offer to Purchase, the related Letter of Transmittal and certain other tender offer documents, as well as the Solicitation/Recommendation Statement, will be made available to all holders of shares of MICROS Systems at no expense to them.
