Compass Group Diversified Holdings LLC and Compass Diversified Holdings (NYSE: CODI) (collectively, CODI) reported that Fox Factory Holding Corp. (Fox) closed on a public offering of 5,750,000 shares held by certain Fox shareholders, including CODI. CODI sold a total of 4,466,569 shares of Fox common stock in this offering, including 633,955 shares sold in connection with the underwriter s exercise of the over-allotment option in full, for total net proceeds of approximately \$65.5 million. Upon completion of the offering, CODI s ownership in Fox was lowered from approximately 53% to 41%.
