You may be wondering, What comes next? and What can I expect upon close? Both of us have heard these questions, so we wanted to give you an overview of what is coming in the days ahead.

Medtronic is expected to close the transaction to acquire Covidien very soon. The final step is obtaining approval by the High Court of Ireland. If the Irish High Court sanctions the arrangement at their January 26, 2015, hearing, the Transaction is expected to close on or prior to January 29, 2015.

This is an exciting and important milestone that will launch the new Medtronic and begin to unlock the potential of our combined company.

For most employees across Medtronic and Covidien locations, there will be no immediate change in how we do our jobs on a day-to-day basis. Employees should plan to continue business as usual unless instructed to do otherwise. A few changes will occur in the first few months post-closing, but for the most part, the integration process and subsequent changes will happen over time. Our goal is to communicate operational changes with you each step of the way.
