(the Company) filed on September 15, 2014, the Company s Audit Committee, which is comprised entirely of independent outside directors, concluded that the Company s previously issued financial statements for each of fiscal years 2011, 2012 and 2013 should no longer be relied upon pending the conclusion of a full internal review described in the report. This internal review is ongoing and could result in findings affecting the Company s previously issued financial statements for any or all of fiscal years 2011, 2012 and 2013. Until this review is complete, the Company will be unable to obtain and compile the financial data necessary to complete the Company s Annual Report on Form 10-K for the period ended December 31, 2014, particularly the comparative columnar data for fiscal years 2012 and 2013, and comparisons to results from such periods, without unreasonable effort and expense.
