Item 1.01. Entry into a Material Definitive Agreement

On August 2, 2017, The Dow Chemical Company (\underline{Dow}) and E. I. du Pont de Nemours and Company (\underline{Du} Pont) received the final required regulatory approval and clearance in connection with the proposed merger of equals transaction of the two companies.

On August 4, 2017, in connection with the Agreement and Plan of Merger (the <u>Merger Agreement</u>), dated as of December 11, 2015, as amended on March 31, 2017, by and among Dow, DuPont, DowDuPont Inc. (f/k/a Diamond-Orion Holdco, Inc.) (<u>DowDuPont</u>), Diamond Merger Sub, Inc. (<u>Diamond Merger Sub</u>) and Orion Merger Sub, Inc. (<u>Orion Merger Sub</u>), the parties thereto entered into a definitive agreement (the <u>Closing Date Agreement</u>), pursuant to which the parties agreed that all conditions to the closing under the Merger Agreement have been satisfied and that the closing of the merger of equals transaction between Dow and DuPont will take place on August 31, 2017.

The foregoing description of the Closing Date Agreement does not purport to be complete and is subject to, and qualified in its entirety by, the full text of the Closing Date Agreement, which is attached as Exhibit 2.1 to this Current Report on Form 8-K and is incorporated herein by reference.

Item 8.01. Other Events.

On August 4, 2017, Dow issued a joint press release with DuPont (a copy of which is furnished herewith as Exhibit 99.1 and is incorporated by reference herein) in connection with the Closing Date Agreement announcing that the closing of the merger of equals transaction between Dow and DuPont will take place on August 31, 2017.
