(1) Represents Deferred Stock Units issued to Mr. Cosgrove by NRG Energy, Inc. under NRG Energy, Inc.'s Long Term Incentive Plan.

(2) Each Deferred Stock Unit is equivalent in value to one share of NRG Energy, Inc.'s Common Stock, par value \$0.01. Mr. Cosgrove will receive from NRG Energy, Inc. one such share of Common Stock for each Deferred Stock Unit he owns twenty-four months from the date of termination of his service on NRG Energy, Inc.'s Board of Directors.

(3) On May 2, 2007, NRG Energy, Inc. announced a 2-for-1 stock split, in the form of a stock dividend paid on May 31, 2007 to all holders of record of Common Stock on May 22, 2007, which resulted in Mr. Cosgrove's ownership of 25,863 additional shares of Common Stock. The Company's Common Stock began trading on a split-adjusted basis on June 1, 2007.

(4) As a result of the stock split referenced in Footnote 3, the shares held by Mr. Cosgrove's wife increased by 10,000 shares.
