- (1) This entry represents the number of shares of ViaSat, Inc. common stock withheld by the Issuer to satisfy the tax withholding obligation of the Reporting Person. - (2) The original restricted stock unit grant was for 5,883 restricted stock units on 11/10/2010. Subject to the Reporting Person's election to defer the receipt of the common stock, the units vest and convert into shares of common stock (on a 1-for-1 basis) at the rate of 1/4 on the 13th month anniversary of the grant date; 1/4 on the second anniversary of the grant date; 1/4 on the third anniversary of the grant date and 1/4 on the fourth anniversary of the grant date.
- (3) Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of employment or service with the issuer.
