- (1) This total includes the purchase of 500 shares on May 14, 2013 under the issuer's Amended and Restated 2007 Employee Stock Purchase Plan.  

The option vests over a period of four years, with 25% of the shares underlying the option vesting on June 6, 2012, the first anniversary of the date of grant, and the remainder vesting in 36 equal monthly installments thereafter, subject to the reporting person's continuous service with the issuer as of the applicable vesting date.
  - (3) The option vests over a period of four years, with 25% of the shares underlying the option vesting on March 7, 2012, the first anniversary of the date of grant, and the remainder vesting in 36 equal monthly installments thereafter, subject to the reporting person's continuous service with the issuer as of the applicable vesting date.
  - (4) The option vests over a period of four years, with 25% of the shares underlying the option vesting on July 6, 2011, the first anniversary of the date of grant, and the remainder vesting in 36 equal monthly installments thereafter, subject to the reporting person's continuous service with the issuer as of the applicable vesting date.
