- (1) The RSUs convert into the Issuer's Ordinary Shares on a one-for-one basis.  
On August 27, 2013 the reporting person was granted RSUs convertible into between 0 - 36,000 Ordinary Shares based on Issuer's determination of the satisfaction of certain performance goals for the fiscal year ended January 31, 2014, which RSUs would then become eligible for time-based vesting. The performance criteria achieved resulted in the grant of RSUs for 36,000 Ordinary Shares to the reporting person.
  - (2) The RSUs vest as to 1/8 of the RSUs on June 15, 2014 and 1/8 of the RSU's will vest each three months thereafter such that the RSUs are 100% vested on March 15, 2016.
