After falling to its 5 month low, gold rebounded and ended December with a gain to finish 2017 above the \$1,300 per ounce level.

Gold and gold stocks performed well in 2017 despite a lack of consistent investor interest and subdued physical demand.

Tax reform in the U.S. is likely to add to the deficit and high levels of debt may lead to a financial crisis.

Although there may be some short-term gold weakness, we believe in the increasing chance of an economic downturn, along with a significant decline in the markets, which supports an allocation to gold.
