Tang Capital Partners is the beneficial owner of 1,507,319 shares of the Issuer's Common Stock, which is comprised of: 3,813.33 shares of the Company's Series C-12 Convertible Preferred Stock, par value \$0.0001 per share (the "Series C-12 Preferred"), 3,009.25 shares of the Company's Series D-12 Convertible Preferred Stock, par value \$0.0001 per share (the "Series D-12 Preferred"), and warrants to purchase 6,907 units, where each unit consists of A) one share of the Company's Series C-22 Convertible Preferred Stock, par value \$0.0001 per share ("Series C-22 Preferred"), and B) a warrant to purchase one share of the Company's Series D-22 Convertible Preferred Stock, par value \$0.0001 per share ("Series D-22 Preferred").

The Series C-12 Preferred, Series D-12 Preferred, Series C-22 Preferred and Series D-22 Preferred can only be converted into Common Stock to the extent that, after such conversion, the holder would beneficially own no more than 9.999% of the Issuer's Common Stock.

Tang Capital Partners shares voting and dispositive power over such shares, preferred stock and warrants with Tang Capital Management and Kevin C. Tang.
