Item 7.01. Regulation FD Disclosure.

On April 23, 2014, Blueknight Energy Partners, L.P. (the “Partnership”) issued a press release (the “Press Release”) announcing that on May 15, 2014 it will pay quarterly distributions of \$0.13 per common unit, a 2.8% increase over the previous quarter’s distribution and a 10.6% increase over the first quarter of 2013’s distribution, and \$0.17875 per preferred unit to its common and preferred unitholders of record as of the close of business on May 5, 2014.
