Subject to certain contractual restrictions, Accenture SCA is obligated, at the option of the Reporting Person, to redeem any outstanding Accenture SCA Class I common shares at a redemption price per share generally equal to the market price of an Accenture plc Class A ordinary share at the time of redemption, subject to an adjustment. Accenture SCA may pay the redemption price with cash or by delivery of Accenture plc Class A ordinary shares. Accenture SCA elected to pay the redemption price for this transaction by delivering Accenture plc Class A ordinary shares.
- (2) Planned disposition of Accenture plc Class A ordinary shares pursuant to a Rule 10b5-1 Trading Plan.  
 The transaction was executed in multiple trades at prices ranging from \$87.21 to \$88.10. The price reported above reflects the weighted average sale price.
