ITEM 8.01 OTHER EVENTS.

On July 30, 2015, the Registrant, through WHLR-Ft. Howard Square, LLC, a Delaware limited liability company (“WHLR-Ft. Howard Square”) and a wholly-owned subsidiary of Wheeler REIT, L.P., a Virginia limited partnership of which the Registrant is the sole general partner, entered into a Purchase and Sale Agreement (the “Purchase Agreement”) as buyer, with Rin South Partners, LLC, a Georgia limited liability company, as seller (the “Seller”), for the purchase of a retail shopping center located in Rincon, GA, commonly known as Ft. Howard Square Shopping Center (the “Property”), for the sales price of Eleven Million Five Hundred Thousand and 00/100 Dollars (\$11,500,000).

Closing on the Property is subject to customary due diligence procedures.

No director, officer or affiliate of the Registrant is affiliated with the Seller.
