### **Item 4. Purpose of Transaction**

Oliver Amhurst acquired 18,080,482 common shares of the Company through a Share Exchange Agreement for investment purposes, but may transfer or sell such shares as necessary and in accordance with applicable securities laws.

Oliver Amhurst has no plans or proposals which relate to or would result in:

- (a) The acquisition by any person of additional securities of the issuer, or the disposition of securities of the issuer.
- (b) An extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the issuer or any of its subsidiaries.
- (c) A sale or transfer of a material amount of assets of the issuer or any of its subsidiaries.
- (d) Any change in the present board of directors or management of the issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board.
- (e) Any material change in the present capitalization or dividend policy of the issuer.
- (f) Any other material change in the issuer's business or corporate structure, including but not limited to, if the issuer is a registered closed-end investment company, any plans or proposals to make any changes in its investment policy for which a vote is required by Section 13 of the Investment Company Act of 1940.

The aggregate number and percentage of common shares of the Issuer beneficially owned by Oliver Amhurst is 18,080,482 common shares, or approximately 31.6% of the Issuer, based on 57,053,138 common shares outstanding as of the Issuers most recently available filing with the Commission on January 24, 2013.

Oliver Amhurst has the sole power to vote or direct the vote, and to dispose or direct the disposition, of 18,080,482 shares of common stock of the Issuer.

Other than as described in Item 3 above, Oliver Amhurst has not effected any transaction in the shares of common stock of the Issuer in the past sixty days.

No person, other than Oliver Amhurst, is known to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, the 18,080,482 shares of common stock of the Issuer.
