(2) 3,098.32 shares have accrued to my account under the KCS Employee Stock Ownership Plan.

(3) 9,551.127 shares have accrued to my account under the KCS 401(k) and Profit Sharing Plan.

These shares represent performance shares that were earned on February 28, 2008 when the KCS Compensation and Organization Committee determined that the 2007 performance goals were met. These performance shares will not vest until January 17, 2010

(4) contingent upon continued employment by the reporting person through that date. With respect to these shares, the reporting person does not have the right to vote, receive, or be entitled to receive, cash or non-cash dividends or any other beneficial rights as a shareholder of the Company.
