There were 8,638,744 shares of common stock entitled to vote at the Annual Meeting, of which 6,677,181 shares were present in person or by proxy. At the annual meeting, our shareholders (i) elected each of the persons listed below to serve as Class III directors of the Company, (ii) ratified the selection of an independent registered public accounting firm, (iii)

approved, on an advisory basis, executive compensation of the Company's named executive officers as disclosed in the proxy statement, (iv) approved, on an advisory basis, that an advisory vote on executive compensation should be held every year.
