- (1) Shares of restricted stock awarded under the Cree, Inc. 2004 Long-Term Incentive Compensation Plan, as amended (the "Plan"). Shares awarded will vest on September 1, 2007 provided Mr. von Arx continues service until that date as a member of the Board of Directors of Cree, Inc. or as an employee of Cree, Inc. or a related "Employer" as defined in the Plan.
- (2) Of the 762,326 shares reported, (1) 68,500 shares are held directly; (2) 594,500 shares are held indirectly in a revocable living trust for the benefit of Mr. von Arx; (3) 30,000 shares are held indirectly in a revocable living trust for the benefit of Mr. von Arx's spouse; and (4) 69,326 shares are held indirectly in a family trust. Mr. von Arx disclaims beneficial ownership of the 69,326 shares held by the family trust.
- (3) The option vests and becomes exercisable as to one-fourth of the shares on each of December 31, 2006, March 31, 2007, June 30, 2007 and September 30, 2007 or, if earlier, upon the election of directors at the 2007 Annual Meeting of Shareholders, provided Mr. von Arx continues service until such dates as a member of the Board of Directors of Cree, Inc. or as an employee of Cree, Inc. or a related "Employer" as defined in the Plan.
