MCNAMARA HOLDS 387,625 SHARES OF THE ISSUER'S COMMON STOCK AND OPTIONS EXERCISABLE WITHIN 60 DAYS OF DECEMBER 31, 2003 TO PURCHASE AN ADDITIONAL 163,750 SHARES. MR. MCNAMARA IS A TRUSTEE OF THE RICHARD MCNAMARA FAMILY FOUNDATION WHICH HOLDS 294,250 SHARES OF THE ISSUER'S COMMON STOCK AS OF DECEMBER 31, 2003. MR. MCNAMARA DISCLAIMS BENEFICIAL OWNERSHIP OF THE ISSUER'S COMMON STOCK HELD BY THE RICHARD MCNAMARA FAMILY FOUNDATION.

(b) Percent of Class: 9.1% BASED ON 9,108,446 SHARES OF THE ISSUER'S COMMON STOCK OUTSTANDING AS OF OCTOBER 30, 2003 AS REPORTED IN THE ISSUER'S QUARTERLY REPORT ON FORM 10-Q FOR THE QUARTER ENDED SEPTEMBER 30, 2003 AND INCLUDING ALL 845,625 SHARES WHICH COULD BE DEEMED TO BE BENEFICIALLY OWNED BY MR. MCNAMARA.
