### Item 3.02 Unregistered Sales of Equity Securities

On October 29, 2004, the registrant issued to Oakwood Financial Services, LLC, a secured convertible promissory note in the principal amount of \$50,000 bearing interest at the rate of ten percent (10.0%) per annum, due January 25, 2005, convertible at the option of the holder, into shares of the registrant's common stock at a conversion price of \$.02 cents per share. Interest is payable in cash.

Additionally, the registrant issued to Oakwood a warrant to purchase 2,500,000 shares of the registrant's common stock at an exercise prices of \$.03 cents per share. Oakwood may exercise the warrant at any time through October  $29,\ 2009.$ 

The sale was made to an "accredited investor", as that term is defined under Rule 501 under Regulation D of the Securities Act of 1933, as amended, pursuant to the exemption from registration requirements under Rule 506 and Section 4(2) of the Securities Act.

The registrant is obligated to register for resale the shares of common stock issuable upon conversion of the note and upon exercise of the warrant on a registration statement filed with the Securities and Exchange Commission on or before December 31, 2004.
