In a Form 12b-25 filed with the Securities and Exchange Commission on May 14, 2001, SSE Telecom, Inc. ("SSET") indicated that it was unable to file timely its report on Form 10-Q for the quarter ended March 31, 2001.

On May 17, 2001, SSET filed a voluntary petition with the United States Bankruptcy Court for the Northern District of California, Oakland Division, under Chapter 11 of Title 11 of the United States Code (Case No. 142831N11). SSET has insufficient resources to collect the information necessary for, and prepare an accurate draft of, its report on Form 10-Q for the quarter ended March 31, 2001. As a result, SSET will not be able to file its report on Form 10-Q for the quarter ended March 31, 2001.

SSET will file the report on Form 10-Q for the quarter ended March 31, 2001 as promptly as practicable following the resolution of the matter referred to above.
