DTE Energy Company ("DTE Energy") will meet with investors at the Deutsche Bank Clean Tech, Utilities & Power Conference in New York, New York on May 14, 2013 and at the Citi Global Energy and Utilities Conference in Boston, Massachusetts on May 15-16, 2013. A copy of the slide presentation from the meetings is furnished as Exhibit 99.1 to this report and will be available on DTE Energy's website, [www.dteenergy.com](http://www.dteenergy.com) on May 13, 2013. In the meetings and in the slide presentation discussed below, DTE Energy reaffirms its 2013 operating earnings per share guidance of \$3.90-4.20 per share and reaffirms its early outlook for its 2014 operating earnings per share guidance of \$4.12-\$4.42 per share.

In the slide presentation and this filing, DTE Energy discusses 2013 and 2014 operating earnings guidance. It is likely that certain items that impact the company's 2013 and 2014 reported results will be excluded from operating results. Reconciliations to the comparable 2013 and 2014 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items. These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
