This Post-Effective Amendment No. 1 to Registration Statement No. 333-90247 is being filed because the registrant's Nonemployee Director Stock Option Plan, as amended (the Nonemployee Director Plan), has been incorporated into the registrant's 2002 Stock Incentive Plan (the Plan), and the shares of common stock that are reserved for future issuance under outstanding awards or available for future grant under the Nonemployee Director Plan are being transferred to the 2002 Plan. The registrant is concurrently filing a registration statement on Form S-8 for the 2002 Plan, which applies in part to the 1,477,000 shares of the registrant's common stock that are reserved for issuance under outstanding awards or available for future award grants under the Nonemployee Director Plan and that were registered on registration statements filed with the Securities and Exchange Commission on November 3, 1999 (File No. 333-90247) (1,000,000 shares) and May 26, 1995 (File No. 33-59623) (700,000 shares). Accordingly, a total of 1,477,000 shares previously registered under the Nonemployee Director Plan are hereby transferred from the Nonemployee Director Plan to the 2002 Plan. The shares listed above reflect all stock splits of the registrant effective through the date of this filing.
