On July 12, 1996, Microsoft Corporation (Microsoft) filed a Registration Statement on Form S-3, SEC 1933 Act Number 333-08081 (the Registration Statement) covering 322,850 shares of Microsoft s common stock (the Common Stock) on behalf of certain Selling Shareholders of Microsoft. Microsoft amended such Registration Statement August 12, 1996 to register a total of 323,0201 shares of the Common Stock.

The Registration Statement was filed in order to register shares of Common Stock issued to former shareholders of eShop Inc. (eShop), a company which had been acquired by Microsoft on June 20, 1996.

Pursuant to the terms of the Agreement and Plan of Reorganization between Microsoft and certain former shareholders of eShop, Microsoft s obligations to maintain the effectiveness of the Registration Statement expired on June 20, 1998. Accordingly, Microsoft hereby de-registers all of its Common Stock registered pursuant to the Registration Statement and remaining unsold thereunder.
