This Amendment No. 3 ("Amendment No. 3") amends and supplements the statement on Schedule 13D filed with the Securities and Exchange Commission (the "SEC") on April 26, 2016 (the "Original Schedule 13D"). As amended by Amendment No. 1 ("Amendment No. 1") filed with the SEC on May 17th, 2016. As amended by Amendment No. 2 (Amendment No. 2). And together with the Original Schedule 13D, Amendment No. 1, Amendment No. 2, and this Amendment No. 3 with respect to the shares of common stock, \$0.001 per share (the "Shares"), of Advent Claymore Convertible Securities and Income Fund (the "Issuer"). This Amendment No. 3 amends Items 3 and 5 as set forth below.

Item Source and amount of funds or other consideration**3.**

Item 3 of the Schedule 13D is hereby amended and restated as follows:

Funds for the purchase of the Shares were derived from the subscription proceeds from investors in SCMF, SCMF II, SCLMF, SCS, SCEF 1 and SCEF 2 and the capital appreciation thereon and margin account borrowings made in the ordinary course of business. In such instances, the positions held in the margin accounts are pledged as collateral security for the repayment of debit balances in the account, which may exist from time to time. Since other securities are held in the margin accounts, it is not possible to determine the amounts, if any, of margin used to purchase the Shares reported herein. A total of \$32,064,903 was paid to acquire the Shares reported herein

Item 5 of the Schedule 13D is hereby amended and restated as follows:
