#### Item 1.01 Entry into a Material Definitive Agreement

On October 31, 2008, Minera San Cristobal, S.A. (MSC), a 65% owned indirect subsidiary of Apex Silver Mines Limited (Apex Silver), entered into an amendment (the Amendment) to the Loan Agreement dated August 11, 2008 (the Loan Agreement) with SC Minerals Aktiebolag, a subsidiary of Sumitomo Corporation (SC Minerals). SC Minerals is the 35% shareholder of MSC.

Under the terms of the Amendment, SC Minerals has agreed to increase by \$25 million the amount available for borrowing by MSC (the Additional Loan Amount). This amount may be used solely to fund MSC s operating expenses. The Additional Loan Amount is in addition to the \$50 million already borrowed by MSC pursuant to the original terms of the Loan Agreement and the \$25 million borrowed by MSC pursuant to the First Amendment to the Loan Agreement dated October 1, 2008. The Additional Loan Amount may be borrowed by MSC at any time on or before December 31, 2008.

Except as stated above, the Additional Loan Amount is subject to the same terms and conditions set forth in the Loan Agreement, as disclosed in the Company s Current Report on Form 8-K dated August 11, 2008. If the full amount available under the amended Loan Agreement is fully drawn (including the Additional Loan Amount), no payments are made by MSC prior to maturity, and SC Minerals were to convert all amounts payable into MSC shares as of the maturity date, Apex Silver s indirect ownership interest in MSC would be reduced to approximately 46.3% (approximately 52.7% on conversion of principal only).
