First Interstate Bank beneficially owns 4,611,316 shares of Common Stock (of which 746,596 shares are Class A Common Stock and 3,864,720 shares are Class B Common Stock), representing 11.0% of the Class A Common Stock and 17.2% of the Class B Common Stock. First Interstate Bank has shared voting and dispositive power over 709,821 shares of Class A Common Stock held as trustee for the Savings and Profit Sharing Plan of First Interstate BancSystem, Inc. and 7,096 shares of Class B Common Stock held as trustee for a Scott family member. First Interstate Bank has shared dispositive power but no voting authority over 3,056,330 shares of Common Stock (of which 21,682 shares are Class A Common Stock and 3,034,648 shares are Class B Common Stock) held as trustee for five Scott family members. First Interstate Bank has sole dispositive power over 703,468 shares of Common Stock held as trustee for twenty-one Scott family members (of which 3,696 shares are Class A Common Stock and 140,807 shares are Class B Common Stock over which First Interstate Bank has sole voting authority, and 7,687 shares are Class A Common Stock and 551,278 shares are Class B Common Stock over which First Interstate Bank has no voting authority). First Interstate Bank has shared voting authority and no dispositive power over 134,601 shares of Common Stock (of which 3,710 shares are Class A Common Stock and 130,891 shares are Class B Common Stock) held as trustee for a Scott family member.
