- (1) Incentive Stock Options ("ISO") granted by the Issuer to Mr. Adams under the Issuer's Stock Option Plans. The ISO is for a term of ten years from the grant date. The ISO vests at the end of years one through four in the following amounts: 20%, 20%, 30% and 30%. The ISOs are fully vested at the end of year four and all options were fully vested as of December 31, 2005. As of the date of this report, there are a total of 20,000 shares of common stock underlying options granted to Mr. Adams.
