- (1) The reported transaction was the settlement of performance shares that were not derivative securities. Thus, there was no price. The performance shares were awarded on January 29, 2009. The performance measures were return on equity and return on sales. On December 13, 2010, the Issuer's Compensation Committee determined that based on the Issuer's actual performance, the Reported Person was entitled to the number of shares reported in Table II. The earned shares are subject to an additional one-year vesting period before they are issued and will vest, as long as the Reporting Person remains continuously employed with the Issuer (with some exceptions), on November 1, 2011.
