Explanatory Note

On August 26, 2015, CVB Financial Corp. (the Company) filed a Current Report on Form 8-K (the Original Form 8-K) reporting the announcement of the appointment of Kristina M. Leslie as a Board member. This Form 8-K/A amends the original Form 8-K to correct the date of Ms. Leslie's appointment and to include information regarding her compensation arrangement.

(d) Appointment of a New Director

On August 24, 2015, the Company announced the appointment of Kristina M. Leslie as a Board Member. Ms. Leslie's appointment was made on August 21, 2015. She was also named a Director of Citizens Business Bank (the Bank), the wholly-owned banking subsidiary of the Company. Ms. Leslie will serve on the Audit Committee, the Nominating and Corporate Governance Committee, and the Compensation Committee of the Company. In addition, Ms. Leslie will serve on the Balance Sheet Management Committee, the Trust Services Committee, and the Risk Management Committee of the Bank.

Consistent with the Company's director compensation plan, Ms. Leslie will be paid a \$60,000 annual directors fee and was granted 10,000 shares of restricted stock to vest over a five-year period from the date of grant. There are no material transactions or agreements between Ms. Leslie and the Company.
