- Mr. Pruett indirectly beneficially owns 296,935 units through his indirect interest in MBN Properties LP, which holds 3,162,483 units. This assumes that the 3,162,483 units held by MBN Properties LP will be distributed to the partners of MBN Properties LP, including
- (1) 191,704 units to SHP Capital LP and 1,447,157 units to Newstone Group Partners. This also assumes that the 1,447,157 units beneficially owned by Newstone Group Partners will be distributed to the members of Newstone Group Partners, including 105,231 units to SHP Capital LP. Mr. Pruett is deemed to beneficially own the units held by SHP Capital LP.
  - (2) 20,000 options were granted on July 17, 2006. According to the terms of the award, the unit options granted vest annually in equal increments over a three-year period beginning March 15, 2007.
